Registration Eligibility:

- A United States citizen
- At least 17 years old, but understand that cannot vote until reaching the age of 18.
- A resident of the county for 30 days before the election
- Person not serving a sentence of incarceration as a result of a conviction of any indictable offense under the laws of this or another state or of the United States.
- Do not Fax or Email Voter Registration forms, The Board of Elections cannot accept electronic registration. Completed form with original signature is required. Please mail, or deliver in-person: Board of Elections, 110 Fifth Street, Salem, NJ 08079
Registration Deadline is 21 days prior to election.
- False or fraudulent registration may subject registrant to a fine of up to \$5,000, imprisonment up to 5 years or both pursuant to R.S. 19:34-1
